Interested Bidders are requested to attend a pre-tender site visit on **Wednesday 24<sup>th</sup> May 2017 at 10.00 a.m.**

1.2 Submission of the following mandatory requirements shall be required in the determination of the completeness of the bid. Bids that do not contain any of the requirements listed below shall be declared non-responsive and shall not be evaluated further.

- a) Must meet all the mandatory requirements as detailed in the tender document.
- b) Single Business Permit
- c) Valid Tax Compliance Certificate
- d) PIN/VAT Certificate
- e) Certificate of Registration or Incorporation
- f) Purchase receipt of Bid Document
- g) Pre-tender Site Visit Certificate
- h) CR 12 showing Directors of the Firm/Company
- i) Fill form of tender in the format provided
- j) Fill Confidential Business Questionnaire
- k) Litigation History
- l) Must quote for all the works as detailed in the tender document.
- m) Must be registered by the National Construction Authority (**NCA 3 and above**).
- n) Must provide a bid bond of **3,500,000** of the bid amount and bank guarantee from a reputable bank or insurance company recognised by PPRA (PPOA) and must remain valid for 120 days from the date of tender opening.

- o) Provide details of similar works completed in the last **Five years**, giving details of the client and consultant.
- p) Provide financial standing (audited accounts and bank statements) for the last **Three years**.
- q) Provide company turnover for the last two years.
- r) Other requirements as per the tender document
