## **INTRODUCTION**

1. This Standard Request for Proposals (SRFP) has been prepared for use by public entities in Kenya in the procurement of consultancy services and selection of consultant.
2. The SRFP includes Standard form of Contract for Large Assignments and small assignment which are for lump sum or time based payments.
3. A separate SRFP has been provided for selection of individual professional consultant.
4. The General Conditions of Contract should not be modified and instead the Special Conditions of Contract should be used to reflect the unique circumstances of the particular assignment. Similarly the information to consultant should only be clarified or amended through the Appendix to information to Consultant.
5. This SRFP document shall be used where a shortlist of consultancy firms already exist or has been obtained through a shortlist after an advertisement of Expression of Interest for Consultancy required.

## **2.1 Introduction**

- 2.1.1 The Client named the Appendix to “ITF” will select a firm, from among the , firms invited to submit a proposal, in accordance with the method of selection detailed in this document.
- 2.1.2 The Procuring entity will provide the inputs specified in the Appendix “ITC”, assist the firm in obtaining licenses and permits needed to carry out the services and make available relevant project data and reports.
- 2.1.3 Please note that (i) the costs of preparing the proposal and of negotiating the Contract, including any visit to the Client are not reimbursable as a direct cost of the assignment; and (ii) the Client is not bound to accept any of the proposals submitted.
- 2.1.4 The procuring entity’s employees, committee members, board members and their relative (spouse and children) are not eligible to participate.
- 2.1.5 The tender document shall be obtained freely from the County Government of Meru website
- 2.1.6 The procuring entity shall allow the tenderer to review the tender document free of charge before purchase.
- 2.1.7 The firms with the technical bids scoring **seventy percent (70%)** and above shall have their financial bids evaluated.

## **2.2 Clarification and Amendment of RFP Documents**

- 2.2.1 , firms may request a clarification of any of the RFP documents only up to **seven [7]** days before the proposal submission date. Any request for clarification must be sent in writing by paper mail, cable, telex, facsimile or electronic mail to the Client’s address indicated in the Appendix “ITF”. The Client will respond by cable, telex, facsimile or electronic mail to such requests and will send written copies of the response (including an explanation of the query but without identifying the source of inquiry) to all invited firms who intend to submit proposals.
- 2.2.2 At any time before the submission of proposals, the Client may for any reason, whether at his own initiative or in response to a clarification requested by an invited firm, amend the RFP. Any amendment shall be issued in writing through

addenda. Addenda shall be sent by mail, cable, telex or facsimile to all invited consultant and will be binding on them. The Client may at his discretion extend the deadline for the submission of proposals.

## **2.3 Preparation of Technical Proposal**

**2.3.1** The invited firms proposals shall be written in **English language**.

**2.3.2** In preparing the Technical Proposal, firms are expected to examine the documents constituting this RFP in detail, in particular the term of reference. Material deficiencies in providing the information requested may result in rejection of a proposal.

**2.3.3** While preparing the Technical Proposal, consultant must give particular attention to the following:

- (i) If a firm considers that it does not have all the expertise for the assignment, it may obtain a full range of expertise by associating with individual consultant(s) and/or other firms or entities in a joint venture or sub-consultancy as appropriate. Consultant shall not associate with the other consultant invited for this assignment. Any firms associating in contravention of this requirement shall automatically be disqualified.
- (ii) For assignments on a staff-time basis, the estimated number of professional staff-time is given in the Appendix. The proposal shall however be based on the number of professional staff-time estimated by the firm.
- (iii) It is desirable that the majority of the key professional staff proposed be permanent employees of the firm or have an extended and stable working relationship with it.
- (iv) Proposed professional staff must as a minimum, have the experience indicated in Appendix, preferably working under conditions similar to those prevailing in Kenya.
- (v) Alternative professional staff shall not be proposed and only one Curriculum Vitae (CV) may be submitted for each position.

**2.3.4** The Technical Proposal shall provide the following information as per terms of reference.

- (i) A description of the methodology and work plan for performing the assignment.
- (ii) The list of the proposed staff team by specialty, the tasks that would be assigned to each staff team member and their timing.

- (iii) CVs recently signed by the proposed professional staff and the authorized representative submitting the proposal. Key information should include number of years working for the firm/entity and degree of responsibility held in various assignments during the last ten (10) years.
- (iv) Any additional information requested in Appendix "A".

**2.3.5 The Technical Proposal shall not include any financial information.**

**2.4 Preparation of Financial Proposal**

2.4.1 In preparing the Financial Proposal, consultant are expected to take into account the requirements and conditions outlined in the RFP documents. The consultant are supposed to prepare bills of quantities and cost as per the design.

2.4.2 Consultant shall express the price of their services in Kenya Shillings.

2.4.3 Commissions and gratuities, if any, paid or to be paid by consultant and related to the assignment will be listed in the Financial Proposal submission Form.

2.4.4 The Proposal must remain valid for 60 days after the submission date. During this period, the consultant is expected to keep available, at his own cost, the professional staff proposed for the assignment. The Client will make his best effort to complete negotiations within this period. If the Client wishes to extend the validity period of the proposals, the consultant shall agree to the extension.

**2.5 Submission, Receipt, and Opening of Proposals**

2.5.1 The original proposal (Technical Proposal and, if required, Financial Proposal; see para. 1.2) shall be prepared in indelible ink. It shall contain no interlineation or overwriting, except as necessary to correct errors made by the firm itself. Any such corrections must be initialed by the persons or person authorized to sign the proposals.

2.5.2 For each proposal, the consultant shall prepare the number of copies indicated in Appendix "A". Each Technical Proposal and Financial Proposal shall be marked "**ORIGINAL**" or "**COPY**" as appropriate. If there are any discrepancies between the original and the copies of the proposal, the original shall govern.



**2.5.3** The original and all copies of the Technical Proposal shall be placed in a sealed envelope clearly marked “**TECHNICALPROPOSAL,**” and the original and all copies of the Financial Proposal in a sealed envelope clearly marked “**FINANCIAL PROPOSAL**” and warning: “**DO NOT OPEN WITH THE TECHNICAL PROPOSAL**”. Both envelopes shall be placed into an outer envelope and sealed. This outer envelope shall bear the submission address and other information indicated in the Appendix “ITC” and be clearly marked, “**DO NOT OPEN, EXCEPT IN PRESENCE OF THE OPENING COMMITTEE.**”

2.5.4 The completed Technical and Financial Proposals must be delivered at the submission address on or before the time and date stated in the Appendix “ITC”. Any proposal received after the closing time for submission of proposals shall be returned to the respective consultant unopened.

2.5.5 After the deadline for submission of proposals, the Technical Proposal shall be opened immediately by the opening committee. The Financial Proposal shall remain sealed and deposited with a responsible officer of the client department up to the time for public opening of financial proposals.

**2.6 Proposal Evaluation General**

2.6.1 From the time the bids are opened to the time the Contract is awarded, if any consultant wishes to contact the Client on any matter related to his proposal, he should do so in writing at the address indicated in the Appendix “ITC”. Any effort by the firm to influence the Client in the proposal evaluation, proposal comparison or Contract award decisions may result in the rejection of the consultant’s proposal.

2.6.2 Evaluators of Technical Proposals shall have no access to the Financial Proposals until the technical evaluation is concluded.

**2.7 Evaluation of Technical Proposal**

2.7.1 The evaluation committee appointed by the Client shall evaluate the proposals on the basis of their responsiveness to the Terms of Reference, applying the evaluation criteria as follows

Qualifications and competence of the key staff for the assignment	15

Each responsive proposal will be given a technical score, ( A proposal shall be rejected at this stage if it does not respond to important aspects of the Terms of Reference or if it fails to achieve the minimum technical score indicated in the Appendix “ITF”).

## **2.8 Public Opening and Evaluation of Financial Proposal**

2.8.1 After Technical Proposal evaluation, the Client shall notify those consultant whose proposals did not meet the minimum qualifying mark or were considered non-responsive to the RFP and Terms of Reference, indicating that their Financial Proposals will be returned after completing the selection process. The Client shall simultaneously notify the consultant who have secured the minimum qualifying mark, indicating the date and time set for opening the Financial Proposals and stating that the opening ceremony is open to those consultant who choose to attend. The opening date shall not be sooner than seven (7) days after the notification date. The notification may be sent by registered letter, cable, telex, facsimile or electronic mail.

2.8.2 The Financial Proposals shall be opened publicly in the presence of the consultant’ representatives who choose to attend. The name of the consultant, the technical. Scores and the proposed prices shall be read aloud and recorded when the Financial Proposals are opened. The Client shall prepare minutes of the public opening.

2.8.3 The evaluation committee will determine whether the financial proposals are complete (i.e. whether the consultant has costed all the items of the corresponding Technical Proposal and correct any computational errors. The cost of any unpriced items shall be assumed to be included in other costs in the proposal. In all cases, the total price of the Financial Proposal as submitted shall prevail.

2.8.4 While comparing proposal prices between local and foreign firms participating in a selection process in financial evaluation of Proposals, firms incorporated in Kenya where indigenous Kenyans own 51% or more of the share capital shall be allowed a 10% preferential bias in proposal prices. However, there shall be no such preference in the technical evaluation of the tenders. Proof of local incorporation and citizenship shall be required before the provisions of this sub-clause are applied. Details of such proof shall be attached by the Consultant in the financial proposal.

2.8.5 The formulae for determining the Financial Score (Sf) shall, unless an alternative formulae is indicated in the Appendix “ITC”, be as follows:-

( $Sf = 100 \times \frac{Fm}{F}$ ) where Sf is the financial score; Fm is the lowest priced financial proposal and F is the price of the proposal under consideration. Proposals will be ranked according to their combined technical (St) and financial (Sf) scores

using the weights ( $T$ =the weight given to the Technical Proposal;  $P$ = the weight given to the Financial Proposal;  $T + P = 1$ ) indicated in the Appendix. The combined technical and financial score,  $S$ , is calculated as follows:  $S = S_t \times T\% + S_f \times P\%$ . The firm achieving the highest combined technical and financial score will be invited for negotiations.

- 2.8.6 The tender evaluation committee shall evaluate the tender within 30 days of from the date of opening the tender.
- 2.8.7 Contract price variations shall not be allowed for contracts not exceeding one year (12 months).
- 2.8.8 Where contract price variation is allowed, the variation shall not exceed 10% of the original contract price
- 2.8.9 Price variation requests shall be processed by the procuring entity within 30 days of receiving the request.

## **2.9 Negotiations**

- 2.9.1 Negotiations will be held at the same address as “address to send information to the Client” indicated in the Appendix “ITF”. The aim is to reach agreement on all points and sign a contract.
- 2.9.2 Negotiations will include a discussion of the Technical Proposal, the proposed methodology (work plan), staffing and any suggestions made by the firm to improve the Terms of Reference. The Client and firm will then work out final Terms of Reference, staffing and bar charts indicating activities, staff periods in the field and in the head office, staff-months, logistics and reporting. The agreed work plan and final Terms of Reference will then be incorporated in the “Description of Services” and form part of the Contract. Special attention will be paid to getting the most the firm can offer within the available budget and to clearly defining the inputs required from the Client to ensure satisfactory implementation of the assignment.
- 2.9.3 Unless there are exceptional reasons, the financial negotiations will not involve the remuneration rates for staff (no breakdown of fees).
- 2.9.4 Having selected the firm on the basis of, among other things, an evaluation of proposed key professional staff, the Client expects to negotiate a contract on the basis of the experts named in the proposal. Before contract negotiations, the Client will require assurances that the experts will be actually available. The Client will not consider substitutions during contract negotiations unless both parties agree that undue delay in the selection process makes such substitution unavoidable or that such changes are critical to meet the objectives of the assignment. If this is not the case and if it is established that key staff were offered in the proposal without confirming their availability, the firm may be disqualified.

2.9.5 The negotiations will conclude with a review of the draft form of the Contract. To complete negotiations the Client and the selected firm will initial the agreed Contract. If negotiations fail, the Client will invite the firm whose proposal received the second highest score to negotiate a contract.

2.9.6 The client shall appoint a team for the purpose of the negotiations.

## **2.10 Award of Contract**

2.10.1 The Contract will be awarded following negotiations. After negotiations are completed, the Client will promptly notify other consultant on the shortlist that they were unsuccessful and return the Financial Proposals of those consultant who did not pass the technical evaluation.

2.10.2 The selected firm is expected to commence the assignment on the date and at the location specified in Appendix "ITF".

2.10.3 The parties to the contract shall have it signed within 30 days from the date of notification of contract award unless there is an administrative review request.

2.10.4 The procuring entity may at any time terminate procurement proceedings before contract award and shall not be liable to any person for the termination.

2.10.5 The procuring entity shall give prompt notice of the termination to the tenderers and on request give its reasons for termination within 14 days of receiving the request from any tenderer.

2.10.6 To qualify for contract awards, the tenderer shall have the following:

- (a) Necessary qualifications, capability experience, services, equipment and facilities to provide what is being procured.
- (b) Legal capacity to enter into a contract for procurement
- (c) Shall not be insolvent, in receivership, bankrupt or in the process of being wound up and is not the subject of legal proceedings relating to the foregoing.
- (d) Shall not be debarred from participating in public procurement.

## **2.11 Confidentiality**

2.11.1 Information relating to evaluation of proposals and recommendations concerning awards shall not be disclosed to the , firms who submitted the proposals or to other persons not officially concerned with the process, until the winning firm has been notified that it has been awarded the Contract.

## **2.12 Corrupt or fraudulent practices**

- 2.12.1 The client requires that the , firms observe the highest standards of ethics during the selection and award of the consultancy contract and also during the performance of the assignment. The tenderer shall sign a declaration that he has not and will not be involved in corrupt or fraudulent practices.
- 2.12.2 The client will reject a proposal for award if it determines that the , firm recommended for award has engaged in corrupt or fraudulent practices in competing for the contract in question.
- 2.12.3 Further , firm which is found to have indulged in corrupt or fraudulent practices risks being debarred from participating in public procurement in Kenya.

### **2.0 Background**

Mariara River originates from Mount Kenya forest and flows a distance of about 36.68 kilometers before it enters River Kathita just below Kiagu Forest. There are several tributaries and other water sources including springs and wetlands within the sub catchment. The catchment covers approximately 122 square kilometers and is divided into five zones namely: Forest Zone, Tea Zone, Coffee Zone, Tobbacco/Cotton zone and Grazing Zone. Over the years Mariara river catchment has been faced with several challenges including and not limited to: Lack of awareness of the community regarding conservation activities, Pollution, over abstraction, planting of unfriendly trees, illegal abstraction, soil erosion, charcoal burning, and cultivation on riparian areas, encroachment of wetlands and springs, water use conflicts among others. The overall impacts of these problems has been a degraded River Mariara Ecosystem which has seen the river drying up especially during the months of January, February, August, September and October when dry spells are experienced within the catchment. Ultimately water use conflicts have also arisen among the many users. It is from this

perspective that the County Government has embarked on a rehabilitation program of the river to restore the rivers ecosystem. The county government is keen on using Bamboo tree species in the rehabilitation program.

### **3.0 Objective**

#### **Objectives of the Assignment**

The principal objective of the rehabilitation program is to ecologically restore river Mariara ecosystem Health to its original state or near its original state while improving the social economic status of the people

#### **3.1 Specific Objectives**

**a) Identify key stakeholders (Government, Private sector, Community, NGOs, civil society, Riparian land owners, water projects etc) that are active within Mariara catchment and having a significant impact on conservation at the landscape level; in doing so, the consultant will:**

- i. Clarify the stakeholders' interest/goals/objectives and categorize them based on their interest in the Mariara River ecosystem
- ii. Provide a quick analysis of the role each stakeholder plays and their potential influence, impact or contribution to conservation of Mariara River and other sensitive areas within the landscape.
- iii. Map/Zone where the different stakeholders' activities are located geographically
- iv. Upon identification of all stakeholders, the consultant to hold different planning meetings to strategize on the road map towards the rehabilitation program. The consultant to develop and plan on the number of meetings and the different schedules. At this stage the consultant will be expected to sensitize the stakeholders on the importance and advantages of using bamboo as the main conservation tree species.
- v. Organize for community sensitization through the media and installation of two Project Sign Posts at strategic location to be identified in consultation with the Department of Environment, Wildlife and Natural Resources
- vi. Identify with all the stakeholders the various interventions for rehabilitating Mariara River Ecosystem and form a project implementation committee

**b) Implementation of River Mariara catchment rehabilitation program, in doing so the consultant will be expected in consultation with the department of Environment, Wildlife and Natural Resources and the identified implementation committee carry out:**

- i. Carry out pegging of the riparian land
- ii. Identify and remove all water unfriendly tree species
- iii. Supply and plant bamboo and other identified tree species along the pegged riparian land. The consultant to demonstrate potential to supply bamboo seedlings in mass.



- iv. Provide a monitoring and protection framework for the planted and growing trees
- v. In consultation with water sector stakeholders develop best water management practices within the catchment

### **c. Review Mariara River Sub Catchment Management Plan**

## **4.0 Scope of works**

To achieve the objectives listed above, the development process will entail:

- The consultant will consult all stakeholders falling within the catchment area
- Rehabilitation program works will entail the first ten kilometers from the forest where the river exits. This is the project area for phase one.
- Review of existing regulatory framework: The consultants will conduct a thorough review of all relevant laws, regulations, statutes and licenses pertaining to water management.
- Collection of data to address the objectives of the rehabilitation program through public consultative forums and key stakeholder interviews.

### **Deliverables**

The consultant is expected to produce the following deliverables:

- Draft reviewed Mariara Subcatchment Management Plan
- Stakeholders' consultative meeting report;
- Provide a monitoring and protection framework for the planted and growing trees.
- Provide phase two rehabilitation program covering a distance of 10 kilometres along the river
- A documentary of all the activities carried out in the first phase delivered in five DVD discs

### **Training Key Qualification, Experience and Skills**

**Key Personnel Requirements** It is expected that the successful bidder will provide an adequate numbers of qualified key personnel for this assignment. Senior staff should have at least 8 years of relevant experience, planning and evaluating large, complex integrated watershed management programs. Communication and IT staff will require a minimum of 3 years of relevant experience and be able to converse fluently in both English and Swahili. Specific personnel linked to defined positions and their relevant experience should be listed in an annex in the proposal. An indicative list of the expected key team members is:

1. Team Leader minimum of Masters-degree in field relevant to participatory catchment management and at least 8 years of experience in planning sustainable land and water management interventions. The team leader should have strong interpersonal and communication skills.
2. Watershed Planning/Natural Resource Management/Environment Specialist should have a minimum of Masters-degree in natural resources management or

related field relevant to participatory catchment management and at least 5 years of experience in planning and implementation of sustainable land and water management interventions using landscape approaches. Alternatively a Bachelors-degree with a minimum of 8 years with relevant experience in community based conservation approaches.

3. Social Development/Community-Based Natural Resource Specialist should have at least a Masters-degree in social sciences/community facilitation or other field relevant to participatory natural resources/water/forestry management and at least 8 years of experience in facilitating implementation of sustainable land and water management interventions. Alternatively a Bachelor's degree with a minimum of 8 years relevant experience. The incumbent should have experiences in participatory community engagement using different tools, e.g., PRAs, resource mapping, strengthening existing community groups and institutions, etc, in relation to more effective and sustainable watershed management.
4. Capacity Building Specialist should have at least a Masters-degree in Social Science or any other related field and at least 3 years of experience in design and supervision of capacity building initiatives in participatory watershed planning and implementation, including development of small-scale soil and water conservation works.
5. Agriculture Specialist should have a minimum of Masters-degree in agriculture/agronomy/livestock management and at least 8 years of experience in agriculture based interventions in land and water management. Alternatively a Bachelors-degree with a minimum of 8 years relevant experience in providing targeted training and technical support to individual farmers and/or clustered groups of farmers along product lines related to crop diversification, water management (including small-scale surface irrigation), conservation agriculture, and livestock production.
6. Communication Management Specialist should have a minimum of Bachelor degree in Mass Communication and 3 years' experience in knowledge management, use of multi-media facilities, graphic designs and desktop publishing. Practical knowledge in mapping software is an added advantage.
